### DESCRIPTION

Pomegranate Juice Frozen 14°Brix is a dark red to dark purple single strength juice produced from mature pomegranates. Product is produced without clarification. The product is safe to use as an ingredient in beverages and other foodstuffs. The product is packed frozen into drums.

### PROCESS

Pomegranates are crushed and the juice is filtered, pasteurized and packed frozen. The concentrate is manufactured under sanitary conditions appropriate for food products, in compliance with applicable laws and regulations including Good Manufacturing Practises (GMP).



### ORGANOLEPTIC

Dark red to dark purple product with a smooth consistency. Product has the typical appearance, aroma and taste of pomegranates with no off-taste or off-odour.

### PACKAGING

Packed into open top drums with lids.  
Safe guarded to prevent tampering.  
Primary packaging comply with relevant EU regulations.

### SHELF LIFE

Shelf life is 24 months at frozen storage ( $\leq -18^{\circ}\text{C}$ ) to maintain sensory, microbiological and physiochemical integrity of the product.
